 - Jim Ujioka Chair



TEC Representatives Attend First Alaska Native Unity Forum



Vice President & General Counsel Brennan Cain and Corporate & Foundation Accountant Rockele Jones represented The Eyak Corporation at the Alaska Native Unity Forum in Anchorage on January 31. The purpose of the Forum was to bring together tribes, Alaska Native Corporations, regional nonprofits, and other entities to discuss Alaska's model of self-determination and how best to collaborate to serve and represent Alaska Native people.

The Chugach region had 18 attendees, representing 10 of the region's 17 Alaska Native entities, with Cheryl Eleshansky representing the Native Village of Eyak and TEC Shareholder Ashley Christensen as a representative for Chugach Alaska Corporation.

The Forum included four breakout sessions in which each region discussed and then reported back to the group on the following topics: How We Manifest Self-Determination; Region Priorities; Rules of Engagement in Our Regions; and Statewide and National Priorities.

The main takeaway from the Forum was that when Alaska Native entities work together, we can accomplish great things for our Alaska Native Shareholders and tribal members!



Business Spotlight: The ANAM Contract

If you or someone you know has ever served in the military, chances are they have taken the ANAM (automated neuropsychological assessment metrics) to measure cognitive performance.


The ANAM is a validated computerized cognitive assessment that has been routinely used for cognitive health assessments for members of the military and Department of Defense.

In 2008, Congress directed that all U.S. Military Service Members receive pre-deployment neuropsychological assessments, with the Government tool of choice being the ANAM. Currently, all Service Members must take an ANAM within 1 year of deployment in accordance with Department of Defense Instruction DoDi 6490.13.

Our EDC Group (Cordova Central LLC, Eyak Services LLC, Controller Bay LLC) currently operates 13 testing locations around the continental United States, mainly at mobilization platforms at military locations and we also manage and operate the ANAM Headquarters in San Antonio on JBSA-Sam Houston. The ANAM HQ is also home to the ANAM data repository where we manage approximately 3.5 M processed ANAM's belonging to our War Fighters. It is the largest data repository of its kind in the world.

The ANAM is especially useful in the assessment of mild traumatic brain injury (mTBI), which is a common condition among military personnel. The ANAM system provides a sensitive and specific tool for the assessment of

mTBI, helping the military to better understand the cognitive effects of mTBI and to develop appropriate treatment and rehabilitation programs for affected individuals.

On February 23, the Eyak Permanent Fund Settlement Trust Committee met and declared a distribution of \$12.55 per share, to be paid on April 7, 2023, to TEC Shareholders of record as of March 31, 2023. The distribution is subject to completion of the annual audit and will be tax-free to Shareholders.

Determining the feasibility of cultural program support; and


Exploring increased scholarship amounts and other programs based on spending requirements and financial modeling data.

We are confident that each of these goals can be accomplished but will require persistence and dedicated effort. We are thankful for generous donations from our Shareholders, Descendants, TEC Board, subsidiaries, and corporation employees. We think the endowment, much like the Eyak Permanent Fund Settlement Trust established by our Shareholders in 1998, will provide significant long-term benefits for our Shareholders and Descendants. We look forward to holding several silent auctions at the upcoming 2023 shareholder meetings. The staff and Trustees are currently working on other fundraising ideas that we hope to share with everyone soon.

Wellness Report: The Importance of Getting Your ZZZ's

A good night sleep is important when it comes to our overall health and wellbeing. When we are deprived of sleep, it can have a domino effect on our life without us even knowing it. The Centers for Disease Control and Prevention recommends 9-12 hours for school age kids, 8-10 for teens, 7 or more for adults 18 and older.

According to an article from MDAnderson Center, 62% of American adults experience sleep problems during the week. Sleep deprivation effects a person's ability to concentrate and think clearly. Lack of sleep has also been linked to heart problems, including high blood pressure and heart disease. Weight gain and diabetes have also been linked to people who do not get a good night sleep. Individuals who have chronic sleep deprivation or insomnia are more likely to show signs of depression too.

Sleep is something we can easily control. Here are a few helpful tips for getting a better night's rest. Be consistent in your sleep schedule and routine. Allowing your body to know when it should be sleeping helps the mind turn off. Flight attendants, nurses, and shift workers that have irregular schedules struggle with finding a consistent sleep routine and it often leads to mental and physical exhaustion. Use your bedroom for sleep only. Try to avoid watching tv or eating in your bedroom, going to bed with a full stomach often leads to a restless night.

Take a moment and make sure your sleep space is one that will allow you to get adequate sleep. Just like other household items that need replaced regularly, the experts suggest replacing your pillow every 1 to 2 years and mattress every 6-8 years. Change your bedsheets and pillowcases often. Allergens built up on linens can also be a sleep deterrent. Face your alarm clock towards the wall and cell phone down as artificial light can disrupt sleep. These are just a few simple changes that can make a big difference in your overall health.


Q. Will The Eyak Corporation's annual Shareholder picnic be held in Anchorage or Cordova this year?


